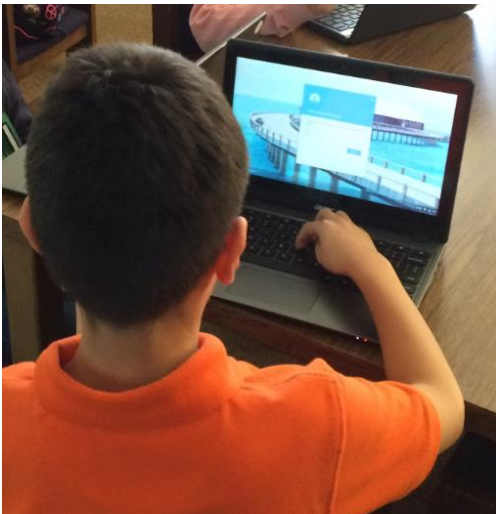

COUNTDOWN TO PARCC FOR LEADERS

DAY AT THE PARCC INFRASTRUCTURE TRIAL RECAP

On February 10, 2016, more than 58,000 students across New Mexico participated in PARCC practice tests using the TestNav App and new Test Administrator (TA) procedures in Pearson Access^{next} (PAN). An additional 12,000 students participated in infrastructure trials on alternate dates in February. Data from PAN and the *2016 Day at the PARCC Infrastructure Trial Survey* provided the Public Education Department (PED) with valuable information about statewide readiness. Specifically:



- The TestNav App works significantly better than browser-based TestNav on all devices *except* Thin Clients (a lightweight computer dependent on servers to fulfill computing roles). Schools that use thin client devices should use browser-based TestNav until the TestNav App is updated. **The TestNav App must be used on all other testing devices.**
- Local caching servers are essential for seamless transfer of data to and from testing computers. **Therefore, all schools or districts must use caching servers for PARCC administration.**
- Test and Technology Coordinators who attended PARCC preparation webinars had the most success with test set-up and administration training. **Webinars are archived at <http://ped.state.nm.us/ped/NMPARCCindex.html>.**
- **Technology Coordinators MUST disable all computer applications that launch automatically, including screen savers, anti-virus software, automatic updates, e-mail message notifications, and low-battery warnings on laptops.** If these applications launch during testing, TestNav will automatically close.
- **TA training for administration in PAN is essential for successful administration.** As outlined in the Test Administrator Manuals (<http://parcc.pearson.com/manuals-training>), TAs must:
 - Receive testing materials from the test coordinator.
 - Log into PAN.
 - Pass out student testing tickets and scratch paper.
 - Read directions from the test script.
 - Unlock the specific test unit in PAN.
 - Time students for the appropriate testing time.
 - Supervise students during testing.
 - Report testing irregularities to the test coordinator.
 - Ensure that students submit completed test units.
 - Lock the test unit in PAN.
 - Collect and return materials to the test coordinator.
