# EQUITY ACT IMPLEMENTATION UPDATE

- Completed data collection for 2018-2019 school year
  - Enrollment for school and athletic participants (female and male) and ratios
- Met with campus level athletic coordinators regarding gender equity and compliance with Title IX
- Attended regional/state NMAA meeting where Title IX was part of the discussion
- Will continue to attend State-level NMAA meetings for all aspects of athletics and activities

### APPROACH TO COMPLIANCE

- #1 Athletic participation opportunities for males and females are proportionate to their respective enrollments.
- #2 Schools are continuing the practice of expanding athletic participation opportunities for all students.
- #3 Equitability across the three locations (Kirtland, Shiprock, Newcomb)

# SCHOOL ATHLETICS EQUITY ACT REPORT


- Assurance form report mandated by the State for all districts

- Report includes baseline data for 2018-2019
  - It includes 7<sup>th</sup> & 8<sup>th</sup> grade athletics and all high school athletics

# KIRTLAND CENTRAL HIGH SCHOOL

- \*473 athletic participants (some students participate in more than one sport)
- •\*Ratio Enrollment- 53% Males: 47% Females
- •\*Ratio Athletes- 59% Males: 80% Females
- Overall athletic participation at KCHS-70% (Males and Females)

### **KCHS Athletics Ratio**




### NEWCOMB HIGH SCHOOL

- \*206 athletic participants (some students participate in more than one sport)
- \*Ratio Enrollment- 57% Males: 43% Females
- \*Ratio Athletes- 78% Males: 98% Females
- Overall athletic participation at NHS-87% (Males and Females)
  - \*\*Increased from 75% to 87% at NHS

### NHS Athletics Ratio




### SHIPROCK HIGH SCHOOL

- \*310 athletic participants (some students participate in more than one sport)
- \*Ratio Enrollment- 52% Males: 48% Females
- \*Ratio Athletes- 51% Males: 57% Females
- Overall athletic participation at SHS- 54% (Males and Females)

### MIDDLE SCHOOL DATA

- Each middle schools' data was also provided in the report
- The middle school data also provides the high schools with early number of how many students will be moving up to high schools
  - \*\*Increased from 53% to 72% at NMS
