### Teacher Residency Program

## One Year Residency

Residents complete a one-year residency working alongside a mentor teacher in a high-need school. During the residency 60% of the day is spent in the classroom and 40% of the day is allocated to completing online coursework requirements.



Small-group practicums allow for application of new knowledge and instructional practices.

Master's Degree Program

#### Online Coursework

Residents complete an online master's degree program at Eastern New Mexico University or another qualified university.



Upon completion of the program, participants are prepared to teach secondary math or science classes or serve special education students PreK-12 and complete the initial licensure process.

## Living Wage Salary

Residents receive a one-year living wage salary of \$55,000 during the residency.

## **Professional Support**

Participants receive intensive, focused professional development, coaching, mentoring, and jobembedded training.

Preparing Leaders Shaping Futures Making a Difference



#### Potential Candidates Must:

- Have never served as a teacher of record.
- Possess a bachelor's degree with a minimum 3.0 GPA from an accredited institution and have a clear background check.
- Secondary math or science candidates must have a minimum of 12 hours of graduate credit or 30 hours of undergraduate credit (12 hours upper division) in a subject matter area that qualifies for an endorsement on a teaching license.
- Special education candidates must have 30 hours general education composite.

- Pass the Praxis Core Academic Skills for Educators: Reading, Writing, and Mathematics.
- Be eligible for admission to the ENMU graduate program or another qualified university.
- Agree to work full-time as a math, science, or special education teacher in a Three Rivers TQP affiliated high-need school for a period of three years immediately after completing the residency.







## Residency Placement

Each participant will complete their residency in a partnering school district. Final approval for placement and specific residency assignment is at the discretion of the partnering district.


The SWTQP partnership includes the College of Education and Technology at Eastern NM University, which has been recognized as a high-quality online teacher preparation program with a 97% student satisfaction rating and extensive experience in implementing teacher preparation programs. ENMU serves a diverse student population (35.6% Hispanic, 42.7% Caucasian, and 2.4% Native American). ENMU is a state approved teacher preparation program, and its master's degree/teacher licensure programs are accredited by the Higher Learning Commission and by the Council for the Accreditation of Educator Preparation. The university will support teacher residents during their online coursework and the teacher residency component. As a member of the partnership, ENMU will collaborate with Three Rivers Teacher Quality Partnership staff to support an effective clinical experience.



Individuals currently participating in a master's degree program at a university other than ENMU might also qualify for the Teacher Quality Partnership residency if the master's degree program from the university meets the same requirements as the master's degree program at ENMU.

New Mexico: Bloomfield Schools, Central Consolidated Schools, Clovis Schools, Cuba Independent Schools, Dulce Schools, Espanola Schools, Farmington Schools, Grants-Cibola County Schools, Las Vegas City, Mesa Vista Schools, Pecos Independent, Peñasco Independent Schools, Pojoaque Schools, Questa Independent Schools, Raton Schools, Santa Rosa Consolidated Schools, Springer Municipal Schools, and West Las Vegas Schools.

Colorado: Alamosa Schools, Archuleta County Schools, Mancos Schools, Monte Vista Schools, North Conejos Schools, South Conejos Schools, and Sierra Grande Schools.

Additional Districts: Districts must meet specific criteria as identified by the United States Department of Education. Additional districts may be considered if resident positions cannot be filled in eligible districts.
